### **Contest Mechanics:**

From 10/08/2026 to 31/12/2026, all Customers on board a Grandi Navi Veloci ferry operating the Italy–Morocco/Morocco–Italy route who, during the promotion period and during the qualifying opening hours of the onboard Retail Shops (hereinafter "Retail Shop(s)"), make a purchase of €50.00 or more in a single transaction\*, will receive directly at checkout one (1) promotional scratch card dedicated to this Contest (hereinafter the "Card").

"Qualifying hours" means exclusively the opening hours of onboard Retail Shop(s) while the vessel is sailing. Periods during which the ferry is stationary or docked at foreign ports are expressly excluded from the initiative. Therefore, purchases made during such periods shall not entitle Customers to receive a Card nor to participate in this Contest.

Customers who receive the Card at checkout must scratch the designated area covered by a removable silver coating in order to immediately discover whether they have won one of the prizes available.

Prior to the start of the Contest, the Promoting Company will print 20.000 Cards, consisting of:

- 600 winning Cards awarding a €30 Shopping Voucher; wording: **"YOU HAVE WON A €30 VOUCHER"**
- 150 winning Cards awarding a €50 Shopping Voucher; wording: **"YOU HAVE WON A €50 VOUCHER"**
- 45 winning Cards awarding a €75 Shopping Voucher; wording: **"YOU HAVE WON A €75 VOUCHER"**
- 5 winning Cards awarding a €200 Shopping Voucher; wording: **"YOU HAVE WON A €200 VOUCHER"**
- 19.200 non-winning Cards bearing the wording: **"YOU HAVE NOT WON"**

Winning and non-winning Cards will be produced in such a way that they cannot be distinguished from one another prior to removal of the covering coating.

All Cards will be randomly mixed and will be identical and indistinguishable.

The party appointed by the Promoting Company to print and mix the Cards will provide a sworn declaration regarding the mixing operations performed.

The following persons are eligible to participate passengers, employees and collaborators of the Promoting Company, employees and collaborators of subsidiary, affiliated and parent companies; employees and collaborators of the Delegated Agency; all personnel working on board the ferries; their family member.

### **Participation and Restrictions:**

Participation in the Contest is exclusively reserved for individuals who are of legal age and who make the purchase as final consumers.

The voucher may be used exclusively at GNV onboard Retail Shops during the same voyage on which it was issued. The voucher must be used before the closing time of the retail outlets for that specific voyage. The voucher is not divisible, does not entitle the holder to change, and cannot be converted into cash.

### **Total Prize Fund:**

The total prize fund amounts to **€29,875.00** (VAT included/not applicable).

### **Documents Required to Validate a Winning Ticket:**

To validate a prize, winners must contact the personnel at the ferry Retail Shop(s) and present the original winning Card; the original purchase receipt that entitled them to receive the Card.

Retention of the original receipt is an essential condition for prize validation.

The Retail Shop(s) Manager will verify that the winner meets all participation requirements; the original winning Card is presented; the Card is valid.

Photocopies will not be accepted. The Card must show no signs of tampering, manipulation, alteration, abrasion, erasure or any other irregularity. Lost, destroyed, damaged, illegible, incomplete, counterfeit, altered or otherwise invalid Cards that do not allow authenticity and validity checks will not entitle the holder to any prize.

For prize validation purposes, the Promoting Company also reserves the right to request the signing of a specific release form; presentation of a valid identity document; proof of purchase associated with the Card; the travel ticket.

Crew members must present, on board, the embarkation certification QR Code that uniquely identifies them.

For special cases (for example foreign citizens and Staff personnel), the relevant data will be entered manually into the cashier system.

Once all checks have been successfully completed, the Customer will receive the prize won. The Promoting Company will record validated wins for the administrative and tax management of the Contest and for compliance with applicable legal requirements.

NB: The shopping voucher must be used before the Retail Shops closes on the voyage during which the winner is travelling.

### **Prize Delivery and Delivery Deadline:**

Winners will receive their prizes directly at the retail outlet upon presentation of the documentation required for validation of the winning Card.

In any event, the latest deadline for prize delivery shall be within six months from the end of the promotional event or from the date on which the prize is requested, as established by Presidential Decree No. 430 of 26 October 2001.

### **Unawarded or Unclaimed Prizes:**
